



Workers' Compensation Insurance Coverage Information

The Minnesota State Fair group insurance policy does not provide Worker's Compensation coverage. However, the Minnesota Department of Labor and Industry requires licensees to provide the Minnesota State Fair with either proof of Workers' Compensation Insurance coverage or a reason for their exemption from this requirement. (Please refer to page 10 in your Information Manual.)

If you do not provide us with a certificate giving evidence of your Workers' Compensation Insurance, you must complete sections A and B of the Certificate of Compliance on the back of this form to indicate that you are exempt from Workers' Compensation requirements.

Minnesota Statutes § 176.182 requires every state and local licensing agency to withhold the issuance or renewal of a license or permit to operate a business in Minnesota until the applicant presents acceptable evidence of compliance with the workers' compensation insurance coverage requirement of Minn. Stat. chapter 176. If the required information is not provided or is falsely stated, it shall result in a \$2,000 penalty assessed against the applicant by the commissioner of the Department of Labor and Industry.

A valid workers' compensation policy must be kept in effect at all times by employers as required by law.
