## HOMEBREW COMPETITION RULES

- 1. The Minnesota State Fair Homebrew Competition is open ONLY to Minnesota residents.
- 2. Registration required. Entries must be registered through <u>mnstatefair.brewingcompetitions.com</u>.
- 3. All rules, entry forms and registration information will be handled by competition officials from the Minnesota Home Brewers Association (MHBA). Registration and complete rules are available on the website <u>mnstatefair.brewingcompetitions.com</u>.
- 4. Entry fee of **\$10 per entry.** Only one entry per BJCP subcategory. Entries will only be accepted from non-professional brewers from Minnesota.
- 5. All entries will be judged according to the style in which they were originally entered according to the BJCP Style Guidelines. Award categories may be combined or split as needed to accommodate limitations in judging.
- 6. Registered entries must be delivered to the following designated drop-off locations starting July 8<sup>th</sup> and ending 5pm Friday August 9<sup>th</sup>.

- 8. DO NOT mail or deliver beer to the Minnesota State Fair. The Minnesota State Fair will not take delivery of any beer entries.
