Kim Schneider resides in Pine City, Minn. with her husband, three Australian Shepherds, sheep, goats, ducks, geese, and chickens. She has been actively involved in herding for over 20 years. She offers stock dog training for all herding breeds at Elysian Farm. She has helped train and trial numerous dogs including Australian Shepherds, Samoyeds, Pumi, Bernese Mountain Dogs, German Shepherds, Koolies and many other breeds. She loves helping each dog use their natural instinct. She is an Australian Shepherd Club of America (ASCA) and American Herding Breed Association (AHBA) stock dog judge.

About the Stock Dog Trials

Object: Stock dogs must handle sheep quietly, easily and confidently while having control and directing movement without injury of any sort.

Scoring: The trials are judged on a "points plus time" scale with times being used to break ties.

Division 1 (Rookie): Limit 6 dogs and a time of 5 minutes

Handler may not have shown any dog at an advanced level in any herding venue. Dogs may not have been shown at an intermediate level in any herding venue. Dogs may not have previously won the rookie division. Handler may accompany the dog. Sheep are released in the arena. Handler may not walk through any obstacle. Course is performed as a fetch, drive or combination. Run ends when the pen gate closes or time expires, whichever occurs first

Division 2 (Novice Ranch): Limit 12 dogs and a time of 7 minutes

Dogs may have not previously won the novice ranch division. Three head of sheep are released into the arena. Dogs gather the sheep. Handler and dog start behind line #2. Handler must maintain a distance of 6 feet from stock/obstacle, except when working bridge, pen or shed. Run ends when the pen gate closes or time expires, whichever occurs first.

Division 3 (Pro Ranch): Limit 12 dogs and a time of 7 minutes

Three head of sheep are released into the arena. Handler remains in center area except when working bridge, pen or shed. Handler must remain in penning circle during the pen to earn full pen points. Run ends when the pen gate closes or time expires, whichever occurs first.

Division 4 (Exhibition Only): Limit 10 dogs and a time of 5 minutes

This division is for dogs or handlers who are not eligible for the other classes but want to experience the Minnesota State Fair. Sheep are released in the arena. Handlers are encouraged to move about the course as necessary to make their dog successful. Run ends when pen gate closes or time expires, whichever occurs first.

COURSE ROUTE

Division 1 (Rookie): 60 Points

- The dog must be set at post #2
 - o The handler may move to within 15 feet of the sheep prior to sending the dog
- Once the handler sends the dog:
 - They may fetch or drive the sheep through the fetch panels, around post #3, then around post #2, then proceed to the pen
 - o The handler may not go through the fetch panels
- Run ends when the Pen gate is shut

Division 2 (Novice Ranch): 90 Points

- Dog starts at post #1
 - Handler may stand anywhere in a straight line between post #1 and #2 to send the dog
- Once the dog is sent, the handler may move to the side of the fetch panels
- When the sheep pass through the fetch panels:
 - Handler may fetch or drive them around post #1 and post #3
- Post #3 is where the handler must stop and:
 - o Drive the sheep through the Drive Panels
 - o Turn right and pass between post #2 and the Fetch Panels and on to the pen
 - When the Sheep Clear post #2 Handler may proceed to the Pen
- There is no Hula Hoop in Novice Ranch
- When the last sheep clears the pen opening, they may close the gate
- Run ends when the pen is shut

Division 3 (Pro Ranch): 105 Points

- Handler starts in the hula hoop
 - Send the dog from their side to gather sheep
- Dog fetches the sheep through the fetch panels
- Around post #1 and between post #1 and the Hula Hoop from Right to Left
 - There is only one attempt to get the sheep between post #1 and the Hula Hoop.
 - Then the handler must move on.
- The team must then get one sheep through every other obstacle before moving on
- Once the sheep pass post #3, handler may leave the hula hoop and proceed to the bridge
- The Sheep go through the drive panels, turn right, and pass between post #2 and the Fetch Panels to the Bridge
- Following the Bridge, proceed to the Pen, where the handler must stand in the Hula Hoop until the last sheep clears the pen opening
- Run ends when they shut the pen


